Palliative nursing shelters evidence-based practice supporting care of end-of-life conditions and illnesses occurring across all settings and has emerged as one of the fastest growing specialties in health care. Although palliative care is crossing all healthcare environments, not all nurses are confident in their knowledge about this specialty and how to apply primary palliative nursing skills into their current practice.

The goal of this day-long course is to support the learning curve vital to advance palliative nursing across all settings for all nurses by establishing a solid educational foundation to empower nurses to lead and transform palliative nursing practice throughout the healthcare continuum.

This course targets nurses all nurses in all settings to include:

- Acute care hospitals
- Long-term care facilities
- Rehabilitation facilities
- Home settings
- Ambulatory or outpatient primary care or specialty clinics
- Veterans' facilities
- Correctional facilities
- Homeless shelters
- Mental health settings
- Institutional settings



Palliative care is defined as patient- and family-centered care that optimizes quality of life by anticipating, preventing, and treating suffering throughout the continuum of illness or injury, through the provision of holistic person-centered care (physical, intellectual, emotional, social, and spiritual) to support autonomy through informed decision-making.

At the conclusion of the 8-hour course, the desired outcomes are for the participating nurse to gain essential knowledge on palliative nursing and escalate his/her role in early advocacy and intervention. Course Outcomes:

1. Synthesize the current state of primary palliative nursing
2. Recognize your greatest opportunities to:
 - a. facilitate communication in advance care planning
 - b. support clinical pain and symptom management as it relates to primary palliative nursing
 - c. recognize the cultural and spiritual components to effective palliative care and the impact on loss, grief and bereavement
 - d. distinguish the nurses' role in end of life advocacy and ethics
3. State 5 primary care settings where palliative care principles can be applied.
4. Construct a plan to apply conversations in palliative care within your individual nursing setting
5. Self-reflect on individual contributions to caring for the dying
6. Integrate 2 self-care strategies to improve nursing resilience

The course utilizes active learner engagement approaches that include self-assessments, case studies, and practice reflection through the incorporation of story-learning techniques and offers participants an 8.0 continuing nursing educational (CNE) credit award through the Hospice and Palliative Nurses Association as a provider of continuing nursing education by the ANCC Commission on Accreditation under provider number Po284. No partial credit is offered.
